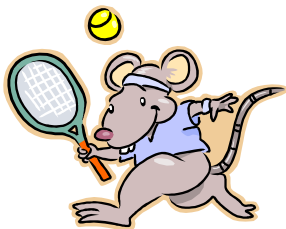

1. Go to [www.USTA.com](http://www.USTA.com)
2. On the top right click TENNISLINK (new page opens)
3. Click Tournaments (new page opens)
4. Under Tournament Links, click RANKING HOME (new page)
5. Select INTERMOUNTAIN –COLORADO, YEAR 2007, and Select DIVISION (ie NTRP, Jr., Adult, etc); and under LIST TYPE, scroll down and select STANDING LIST.
6. Click FIND IT. All players will be in Standing List order. Click on player's name and the entire record will be displayed.

## LEAGUES, LEAGES, LEAGUES

Teams are forming and registration is open for those teams with LTA and USTA paid members. Practices and drills are starting.....[Let the fun begin!](#)

**2006 & 2007 TEAM CAPTAINS:** You are our point of contact for organizing 2007 league teams.

**It is critical** you understand that before you can get your team number from the coordinator to register for league play, you need to verify that all team members have paid their 2007 Lakewood Tennis Assn membership dues and that you provide a roster of at least the minimum number of players required, by the league registration end date. This roster must include team member name, phone number, and e-mail address (information you already have). Also ensure that your team members have registered with USTA by the appropriate date.

We mentioned in the last 2 newsletter that **CTA has gone electronic** – what a novel idea – and have put their newsletter on the website. **Captains will NO LONGER receive packets in the mail** as they have in the past. Everything should be available on line. You need to sign up for the BLAST at their web site – [www.coloradotennis.com](http://www.coloradotennis.com). You will receive your information via e-mail. Please go to the site and get into the league information and become familiar with how to find what you need. If you do not have e-mail, you will need to call CTA and request paper documents be mailed to you. CTA’s main office number is 303-695-4116.

**USPTA** (U. S. Professional Tennis Assn) **2007 Women’s Doubles Spring Tennis League** will run from June 7 – July 26 with championships July 28 & 29. Rosters and fees are due May 1<sup>st</sup>. A team consists of 4 ladies – 2 doubles matches. Cost is \$50.00 per team. Play is Thursday’s 9:00-11:00 AM. 2.5 thru 4.0 levels are offered. **World Team Tennis** season start and end dates remain unchanged – June 15 thru Aug 3. More info to come.

## RITA’S REVIEW

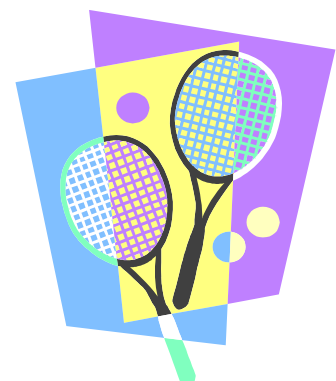
