**Minutes** from the June 3<sup>rd</sup> meeting were approved by Ellen and Josh with one correction. The June board meeting was held at the home of Linda Maisonneuve.

## Committee Reports

**Tournaments:** The Lakewood Tournament will be July 11-15. Forty are signed-up; we would like 100. Registration closes next Sunday, July 8<sup>th</sup>, at midnight. Some players may have conflicts with their USTA league games. Josh will make necessary arrangements for all to play both league and tournament matches. Ron arranged with the City for equipment storage to be at Lakewood Park. Volunteers are needed for set-up and drinks. Sue volunteered. Draws will be posted on the tournament website by Monday, July 9<sup>th</sup>. Please let Josh know if you can help.

**Vail:** Dates are September 21-23. Early registration will be \$90 per person. After August 15<sup>th</sup> the price will be \$110. Same great deal as previous years except this year dogs will not be allowed.

**Membership:** Harold reported 218 total members including some corporate sponsors. 162 members receive The Lobber electronically. 64 rooster booklets were mailed.

**Newsletter:** Jeanie needs all information by July 25<sup>th</sup> for the August Lobber.

**Webmaster:** Sue is working diligently and will update us at the August meeting.

**Intra Club Coordinators:** Tom's report was given by Linda. Twilite will have 3 men's teams. Seniors will also have 3 men's teams.

**Women's:** Twilite will have 1 team and Seniors will have 4 teams. Fall Mixed is still pending. Anthony made the suggestion that all teams that are going on in competition should be listed in The Lobber. We wish them luck in their matches.

**Treasurer:** Linda reported our current cash balance at \$8,298.00. Josh has reported \$2,614.00 thus far in expenses for the Lakewood Tournament. Discussion followed concerning the status of our socials. The June social was very small and we lost money. Maybe we need better promotion. Perhaps the registration form still

needs to be in The Lobber. More prizes and the possibility of inviting other clubs were mentioned.

**New Business:** Linda reported that CTA would like every tennis club to have just one home court that can be published with an address. Problems have occurred with captions not having the correct location for matches. Linda mentioned an important guideline: 48 hours prior to a match telephone notification should be given to the opposing team caption with correct location and facility description (bathroom, water, etc.). Discussion followed concerning our club. Anthony moved that Lakewood Courts be our primary location. Seconded by Jeanie. Linda Wenz will continue as the contact person with her telephone number and address being published. She will carry team schedules to assist with last minute problems. Motion carried.
